The proposal is to remodel the existing link walkway to the entrance of the college, the intention is to bring the area up to modern standards and ensure that the roof is watertight.

It is proposed to retain the existing foundations and footprint for the link walkway. The proposal is to retain the existing framework (Brick wall), the height to be as per the proposed drawings. Structural investigations and soil pit surveys have been carried out and we have been advised we can retain the existing structure.

We propose new Pilkington Insulight™ Therm double glazing Timber Sash windows with painted timber fascia boards all to match the current buildings style, colour and characteristics.

The proposed flat roof will be warm deck construction using the StressPly Flex Plus system offering ultimate multi-layer waterproofing protection.

All works will utilise building materials that are sympathetic to the existing building construction and will match existing so as not to detract from the character of the building and surrounding area.

Explanation for Proposed Demolition Work

Why is it necessary to demolish all or part of the building(s) and/or structure(s)?

We have carried out structural investigations and soil pit surveys and have been advised we can retain the existing structure. The existing structure comprises of solid brickwork in Flemish bond with a number of the bricks being blown therefore, re-pointing and maintenance works will be carried out to ensure the retained existing brick wall is in good condition.

One key motivation behind these modifications is to address the complexities and problems associated with the current design. The existing structure consists of three different roof sections, which has created challenges in terms of maintenance and water ingress. The voids between the flashings and the elevation have been particularly problematic, causing water to seep into the structure. By transitioning to a flat roof design, we aim to simplify the structure and eliminate these complexities. A flat roof will allow for better integration of the flashing and elevation, minimising the risk of water ingress and subsequent maintenance issues. This modification will not only enhance the longevity of the structure but also reduce the need for ongoing repairs and associated costs. We believe that the proposal is in keeping with the architectural detailing of the front façade and reflects other lower-level protruding building elements such as the main entrance which comprises a similar structure with flat roof above. We have considered the window fenestration in our design and will look to maintain this whilst reducing the height of the windows from to align with the existing front facade windows.
