Thank you for your e-mail and attachments.

As it varies significantly from the original approval 21204C/87/1363 with regards to the shape and design of the earlier conservatory I can confirm that planning permission will be required for the verandah.

If it is free standing and not attached to the house (and no higher than 2.5m) it won't require planning permission.

Given the fact that the conservatory could be implemented tomorrow I do not envisage significant planning issues with the verandah submission (privacy?), but I have been wrong before!
