The Proposed Single-Storey Rear Extension and the Loft Conversion are both "Permitted Development". The Extension has a maximum depth of 4m and the ridge height is also maximum 4m.

The submitted plans confirm that the proposed development would:

1. Not exceed the permitted development allowance of 50 cubic metres (detached property).
2. The dormer would not project forward of the plane of a roof which forms a principle elevation or fronts a highway.
3. The roof extension would not encroach on neighbouring properties.
4. The roof extension would not be higher than the highest part of the roof.
5. The dormer would be set in from the eaves margin by 200 mm.
6. The proposed rooflights would not project more than 150 mm beyond the plane of the roof.
7. Permitted development rights have not been removed and
