Proposal amended to suit the pre-app comments. In particular, the detached garage has now been redesigned to be attached to the house and as such, allowing a gap of more than the minimum 1.5 metres required. The first floor side extension has been set back to ensure it appears sub-ordinate. The ground floor rear extension has been reduced with only a glass link proposed to connect the outbuilding - ensuring minimal impact.
