



PROPOSED FRONT ELEVATION




PROPOSED REAR ELEVATION




PROPOSED SIDE ELEVATION




PROPOSED SIDE ELEVATION




PROPOSED SECTION



PROPOSED GROUND FLOOR PLAN




PROPOSED FIRST FLOOR PLAN
