Description of Proposed Works

Please describe the proposed works

Erection of an open front porch. This is retrospective planning application. The approach to our front door was steep with high steps and some of the stones were damaged. We decided to revamp this by building a porch with more moderate and safer steps especially for my mother who is 78 and young children.

We engaged a builder and agreed the plans the dimensions were 2.14m by 1.4m. We were very clear that the porch dimensions should be within the specified regulations so not more than 3m squared.

Whilst the work was in progress the builder went on holiday leaving his team in charge who continued with the work and finished the porch frame.

When we received a visit from your colleague, it became apparent that the porch measured 20cm more taking us just over the intended 3m squared specification. Needless to say we were surprised and concerned.

The porch is not a liveable space, it is open and so we are not able to use it for storage or anything else. The open porch merely provides cover from the rain when entering and leaving the house and enables my elderly mother to safely enter and leave the house through minimising the strain on her knees.

Given where we are, I have no option but to request retrospective planning permission. I am not able to take the porch down or adjust it as both of these actions would incur significant financial outlay. I therefore request that the council review the circumstances and grant retrospective planning permission. We had no desire or intent to build something outside of the specified regulations nor to breach any rules/policies.

I hope that you will compassionately give full consideration to the circumstances and grant retrospective planning permission
