The refusal gave 2 reasons to refuse. The first relates to bulk and massing and this resubmission addresses that reason by providing for 1.5metres flank boundary distances (increased from 1.2metres) and also a redesigned roof profile that includes a lowered flank eaves line. The second reason relates to the lack of a tree report and this is now provided which fully supports the redesigned proposal here.
