T261 Large Quercus Robur within waterlogged ground in decline with poor buttresses.

- Reduce to Monolith at approx 8m to minimise risk of failure onto adjacent property. (TPO W26)

T266 Large, mature declining Oak in waterlogged ground with brackets of Ganoderma australe on south side of stem

- Reduce to approx 8m monolith to minimise risk of failure onto adjacent property. (TPO W26)

T9 Mature Scots pine on corner between driveways

- Perform aerial inspection to assess condition of tear out wound and damaged branch at approx 16m

T74 Large Common lime on south east end of Harrington house,

- Remove deadwood throughout crown
- Remove basal and lower stem epicormic growth to give space to building

(Conservation Area CA-4)

T77 Large Ash overhanging from behind wall.

- Remove deadwood throughout.

T142, Mature Oak on roadside boundary at south entrance to site

- Remove lowest limb over Swakeleys drive
- Reduce remaining overhang by approx 3m to give clearance to highway.

T143 Large mature Oak on roadside boundary at southern entrance to site.

- Remove deadwood throughout crown

T155 Dead Small leaf lime adjacent to footpath

- Dismantle in sections to near ground level

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
