4. Materials shall be similar in appearance to the existing house.
5. No part of the extension to be higher than the highest part of the existing roof.
7. Side-facing windows shall be obscure glazed and non-opening unless the parts which can be opened are more than 1.7 metres above the floor of the room in which it is installed.
8. No roof windows shall protrude more than 0.15 metres beyond the plane of the slope of the original roof when measured from the perpendicular with the external surface of the original roof
9. The new Dormer Roof shall be set back over 20cm from the original eaves.
