The proposed work entails the removal of the existing single-storey utility room (1.5W x 3.1L x 2.5H meters) on the side of the property, followed by the construction of a new single-storey side extension (trapezium in shape 2.1/2.65W x 10.98L x 2.65H meters), which will serve as a replacement utility room.

Within the scope of the project, a door will be integrated into the bungalow to establish a seamless connection between the utility room and the living room. The new side extension will feature two external entrances, one accessible from the back garden and another from the front garden. To maintain visual harmony with the existing bungalow, the extension will be constructed using the same materials, notably red bricks, to achieve a cohesive and integrated appearance. Adequate natural lighting will be ensured through the incorporation of roof lights in the extension's design, contributing to an inviting and well-illuminated interior space.

Additionally, the private manhole on the property will be relocated forward by 4 meters, facilitating easier access to the drainage system. This accommodates the direct drainage of wastewater from the utility room (housing washing machine and sink) into the relocated manhole. This design feature supports efficient wastewater management and reduces potential disruption.

Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The proposed side extension falls within the scope of Class A permitted development rights. It adheres to the requirement that the total area of structures within the property's curtilage, excluding the original dwellinghouse, remains below 50% of the overall curtilage area. The eaves of this single-storey extension do not surpass the existing bungalow's eaves' height. The extension's dimensions are restrained to less than half the width of the original dwelling. In keeping with the existing bungalow, the proposed extension employs akin materials. This envisioned extension is intended for use as a utility room, and it will incorporate a new entrance that seamlessly connects to the kitchen-diner area. Its purpose is to enhance the functionality of the property without introducing any change of use.
