The Pre App response was issued as an uneditable PDF so we couldnt paste it in here but it in essence the planning officer was against the large GF rear extension and the initially proposed full width rear extension. They advised that it might be possible to achieve some form of full width extension if we stepped it back considerably but this would need to be considered at planning stage. The FF front addition might be considered but the advice was to not project beyond the lines of the existing building and for all materials to match existing.
