The proposed development includes the renovation, energy upgrade and extension of an existing semi-detached dwelling of c.96sqm, to include a part single-storey, part two-storey side and rear extension of c.40sqm [30.5sqm on ground floor and 9.5sqm on first floor], with the rear extending not more than 2.3m from the existing dwelling, to align with the adjoining property ['Catlins']. The side extension is set back 1m from the shared boundary. The roof forms of the first floor additions are smaller in volume than the existing with new ridges set down from the existing, and are of matching traditional style: sloped and tiled. All materials to match existing.
