Falling branches have caused injuries to a landscape worker, my grandchildren and myself.
The landscape worker was taking Warfarin and as bleeding from his arm wouldn't stop, he had to attend Emergency Dept.
severe damage to garage roof. HEAVY MOSS. Broken tiles due to falling branches.
From early September to mid December we have a huge amount of acorns and leaves dropping on the drive.
This makes the drive slippery and walking becomes hazardous. My wife and I are senior citizens. A fall could result in fracture, particularly a hip fracture, with serious consequences.
We have 2 more oak trees closer to the front fence which make matters much worse.
Subsidence. Front and side wall cracks.
Drainage problems.

I have planted several trees in the bac garden including Eucalyptus, Magnolia grandiflora, liquidamber styraciflua x 2, several Italian cypress trees, Catalpa, Arbutus unedo and a Chanticleer.

I have seen several fallen multi stem trees in Swakeleys Park. The tree in our garden is a serious hazard and a danger to property and life.
