Details of the pre-application advice received

During our meeting we discussed the proposal she was happy with the proposal including the depth of the side and rear extension but had one objection which was the front position of the side extension which would make the proposal unacceptable, she said once I pulled back the side extension to the original front wall of the house and pulled back the pitched roof over that section the proposal would be acceptable. The planning officer came to the conclusion as there were sizeable additions to other properties in the local area (e.g. No 9 and 11 Hamilton road) the proposed alteration would not be an incongruous addition to the character of the wider area and would not cause undue harm to the living conditions of neighbouring occupiers. The existing two car park spaces were sufficient. Providing the side extension and its part pitched roof was set back from the porch and starting at the original front face of the front wall she would consider the proposal acceptable. The revisions have been made to the set of planning drawings being submitted in accordance with pre- app advise.
