The proposed single storey rear extension will be added to an existing rear single storey extension to create a 4m deep extension when measured from the original rear wall when the house was first constructed. The extension will be finished in brickwork to match existing masonry and have a new GRP water proofing system for the flat roof. A new fully glazed non opening roof lantern will be installed to provide natural light into the dining room.
