Thank you for confirming the address and providing details of the proposed structure.

I can confirm that the structure accords with the provisions of Class E of the General Permitted Development Order 2015 so would not require planning permission if constructed in accordance with the drawing dated the 28th of December 2020.

The limitation on a "bathroom" (as well as a kitchen and bedroom) is really there to prevent possible sub-letting of the structure as a separate unit and Inspectors have acknowledged that a toilet and shower are incidental to domestic gym usage-very wisely I would suggest. I think the guidance needs to change with the dramatic change to home working currently underway.
