The proposal is to construct 2 x changing rooms, 2 x toilets and a reception area. The rest of the space will be used as an open planned gym. No other changes will be made to outside structure of the football club.

The plan is to operate this Gym on a 24 hours basis. In order to enable this all the clients will have access to the gym via the turnstiles which will be situated on the ground floor. When the Gym will not be staffed, clients will be able to enter using their fingerprints on the scanner provided. Although the location of the proposed Gym is not near residential premises, clients will be encouraged to leave the Gym as quietly as possible during the night. Signs will be placed inside the Gym to encourage clients to do so.
