Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The proposed outbuilding should be considered permitted development for the following reasons:

1. The property is located in a Designated Area however the proposed outbuilding is not to the side of the existing house
2. The site is not located within a national park, the Broad, Area of Outstanding, Natural Beauty or World Heritage Site
3. The outbuilding is not forward of the principal elevation of the original house
4. The outbuilding and other additions shall not exceed 50% of the total area of land around the original house. The local authority uses a maximum figure of 30sqm for outbuildings however, the rear garden of the application site is very large with an area of 605sqm. The proposed outbuilding will have a footprint of 48.5sqm. Following development there shall still be 556.5sqm of rear garden space remaining and therefore the increased size should be considered acceptable in this instance.
5. The new building shall not contain separate, self-contained, living accommodation
6. The new outbuilding is within two metres of the property boundary and therefore shall not exceed 2.5 metres in height.
