## 7. Identification of Tree and Description of Works

To carry out tree maintenance on T1 at TP 247, a mature oak, including a crown thin of 10%, a crown reduction of 2-3 metres and a crown lift of 1.5 metres, as previously carried out works and approved by the London Borough of Hillingdon on 17 June 2010.

The work is required due to reach of branches within 1 to 2 metres of 45 Woodstock Drive. Tree is also excessively overshadowing more than 50% of neighbours property at 11 Malcom Road, and 45<sup>45a</sup> Woodstock drive, as well as pressing aggressively against adjacent TPO trees T4 and T5.

There has also been large branches falling into the gardens from recent storms which is hazardous to children playing in the garden at 11 Malcolm Road.

We recommend this work to protect property, health of TP1 and neighbouring trees.

Also, this is a follow up application to a previous application. We have scaled down our request from 20% to 10%. I have attempted to discuss this with your department numerous times by phone and email but you have not returned my calls. I can only hope you view this application more positively than the last one. Best Jon.
