Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The property is not located within a Conservation Area, the ground floor side extension does not exceed half the width of the original house, the highest point of the roof will not exceed 4 metres and any part of the roof falling within 2 metres of house no. 55 'neighbours' boundaries will be a maximum height of 3 metres.

The rear dormer / Loft conversion will not be higher than the highest point of the current roof ridge, the dormers will be set back a minimum of 20cm from the eaves and the internal loft staircase will have at least 2 metres head height clearance.

The total increase in roof volume and ground floor side extension will not exceed 50 cubic metres as a semi-detached house / bungalow.
