We discussed the comments of Councillor Higgins at the Planning Committee meeting on Wednesday 10th May 2023 when he stated the Black Horse would be given the opportunity to resubmit the planning application with a revised design to find an acceptable solution for the Karoga Gazebo's which were felt to be unsightly.

The Senior Planning Officer stated that the retractable awning was acceptable in principal and that one TV might be viewed in a more positive light.

On this basis we have removed the Karoga and one TV from the resubmitted application.

The intention is to submit a pre application for a Karoga Solution that will be acceptable to all parties.
