T1 Oak of MWA / Crawco Arb Report

Works: Reduce height from 16.5m to circa 14m and Reduce lateral RADIUS to 8m which would leave a lateral SPREAD of 16m leaving balanced crown, leaving a well-balanced crown (in accordance with BRE IP7/06 "Pruning trees to reduce water use" to mitigate root induced clay shrinkage subsidence.

Reason: Clay shrinkage subsidence damage at subject property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
