The side and rear extension of the house is different to the drawings referred to in the planning consent (27921/APP/2017/1280). In particular, it is single storey (rather than double in the consented plans), there are three skylights rather than one and the internal arrangements are slightly different.

The outbuilding at the end of the garden doesn't have planning consent and is used as a home office/ storage/ playroom/ guest room.

Both the house extension and outbuilding have existed for more than 4 years.
