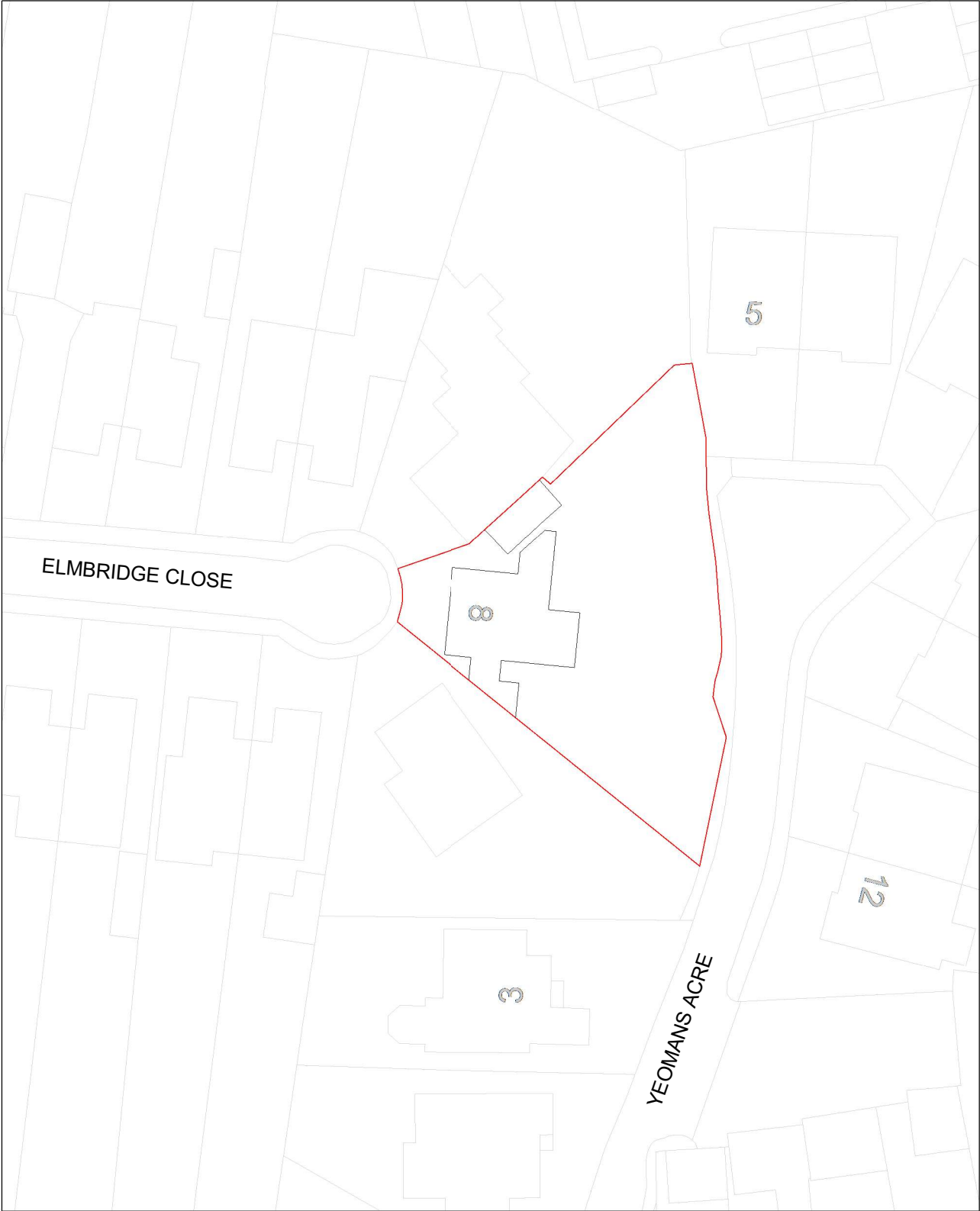
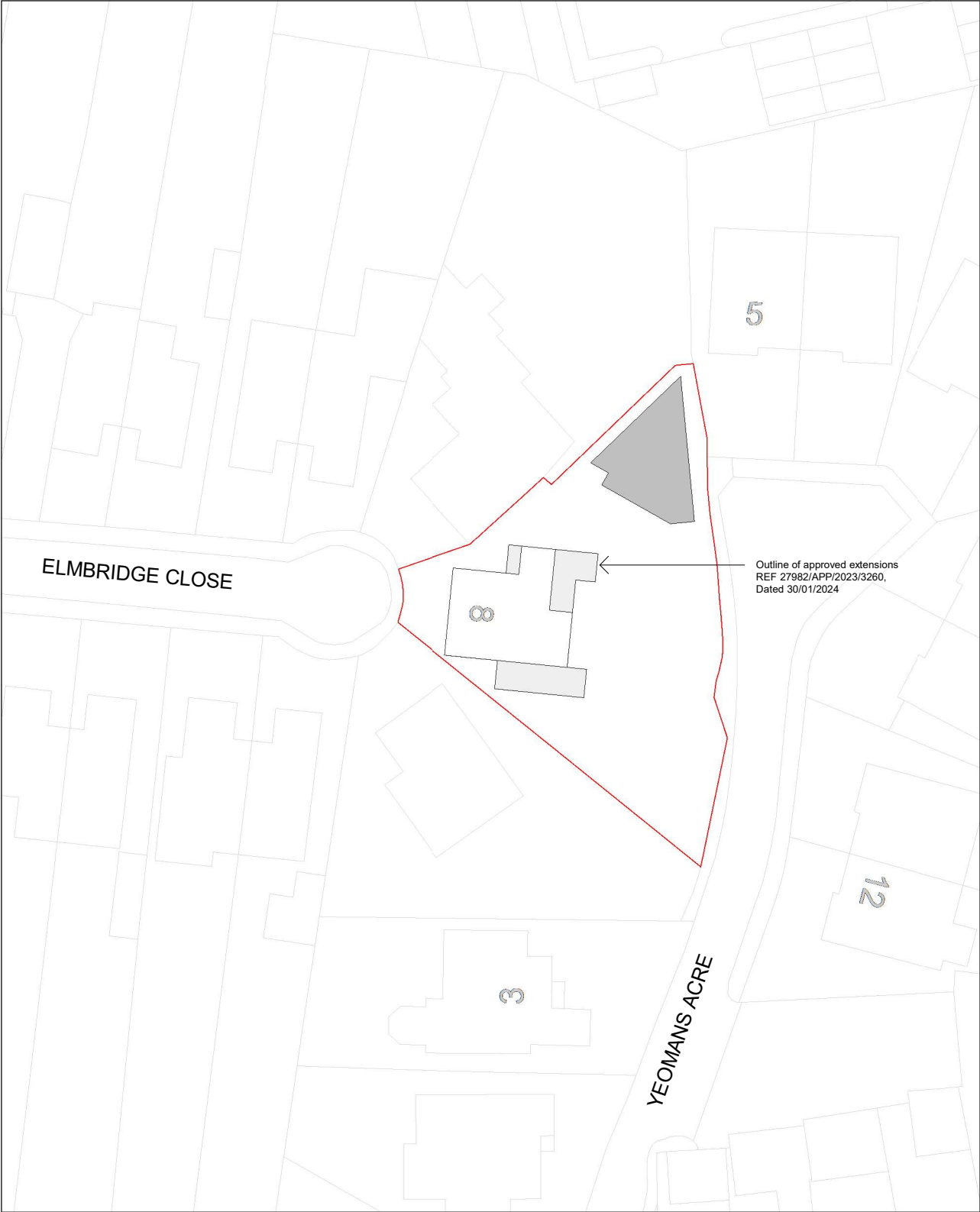


Block Plan Existing

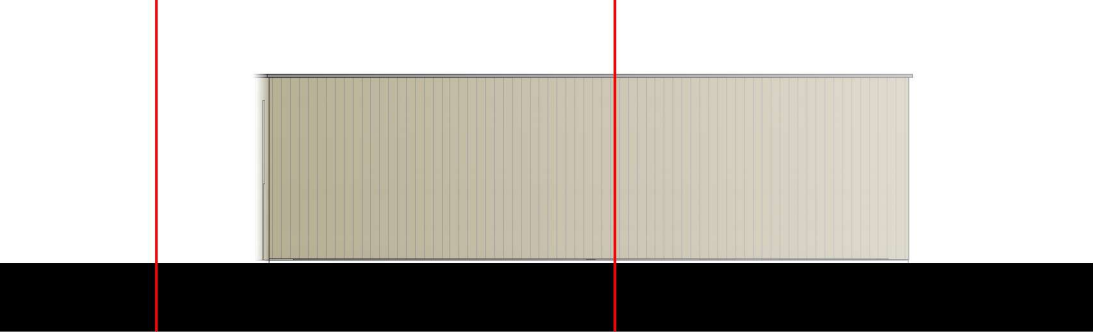
Roof Plan

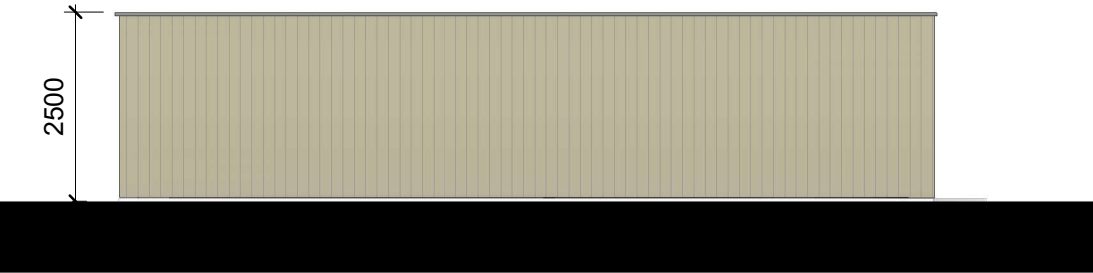
Front Elevation
