#### Conclusion

There is no objection in principle to the proposals to extend to the property. However, the proposed extensions, by reason of their siting, size, scale, bulk, and design, including a large crown roof, would fail to appear as subordinate additions and would fail to harmonize with the architectural composition of the original dwelling. The pre-application scheme is considered to fail to preserve and enhance the character and appearance of the Ickenham Village Conservation Area. There are also concerns raised regarding the residential amenities of neighbor No.33 as it appears the two-storey element may impact their side windows which serve habitable rooms.
