In particular, application ref. 28177/APP/2024/620 which confirmed that alteration works to the existing building were considered permitted development. In confirming the changes were lawful, it can be deduced that the dwelling must fall within use Class C3.

In terms of the proposed use, to convert the dwelling into a HMO (C4), this constitutes permitted development, as set out in Schedule 2, Part 3, Class L of The Town and Country Planning (General Permitted Development) (England) Order 2015.
