Conversion of existing garage into living accommodation. All work will be internal with no enlargement to the building. Garage door to be infilled with new wall and window to match existing brickwork and window on front of property. This will be a UPVC window 1840 mm x 1090 mm (Eco Energy Plus A rating) and incorporates a 620mm x 1060 mm openable window to allow emergency egress. Floor to be levelled where necessary and upgraded to ensure adequate damp proofing. Existing exterior wall of garage (adjacent to 274) to be damp proofed and insulated. Existing ceiling of garage to be panelled to allow for recessed lighting and insulated. No change to existing roof pitch with roofing material and guttering to be upgraded if necessary. Internal access to be obtained by knocking through internal walls from living space at front of property and room at rear of property. Heating will be through extension of existing central heating system
