I hope you're well?

As part of the GLA referral for the site, the GLA have recommended we contact the Local Borough Energy Officer to determine if there are any existing or planned local district heating networks in the vicinity of the site. Our energy consultants have consulted the London Heat Network Map and the site is rated as 'zero' on the heat density scale and is not within a heat network priority area. The nearest planned or existing networks are in Uxbridge around 5 miles south of the site, however if the Local Authority can confirm if there are any networks they are aware of outside of the network map, this would be appreciated.
