Further to our email of 17/9/2024, we are only able to purchase Prunus shogetsu trees of **150-200cm size** as the larger ones are no longer in stock.

We can either go ahead with Prunus shogetsu trees of the above size or instead depending on stock availability, we are happy to plant one of the following species as they also support and are wildlife friendly:

- a) Prunus Accolade - 2 to 2.5m in height
- b) Sorbus Pink Kirsten Mountain Ash - 2 to 2.5m in height
- c) Japanese Flowering Cherry - 2 to 2.5m in height

The two replacement trees would be planted in the two positions advised in our earlier email today.

Please advise soonest whether you have any concerns with the above proposal as we'd like to order the trees asap given fluctuation in stock availability.

We propose to plant two "Flowering Cherry Blushing Bride Trees - Prunus shogetsu" which will be 2 to 2.5m in height. These are rated by RHS as "Plants for pollinators" and thus will help attract bees and wildlife and aid general health of plants in the area by supporting pollinators. They will be

planted towards the end of the garden which benefits from most sun in the garden so as to help them flourish.

Please let me know within the next 10 days if you have any objections to this plan as I'd like to order and plant them as soon as possible.
