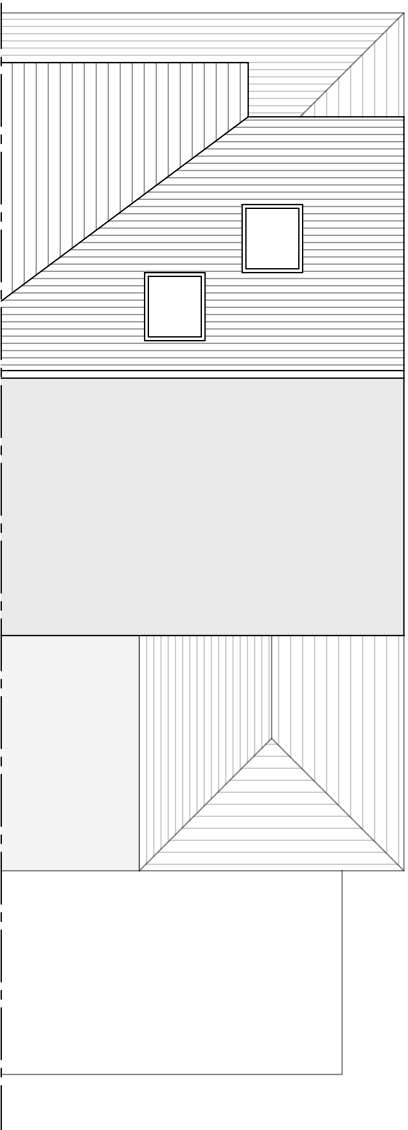
GROUND FLOOR PLAN



FIRST FLOOR PLAN



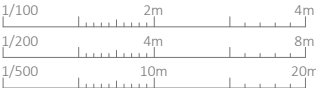
LOFT FLOOR PLAN



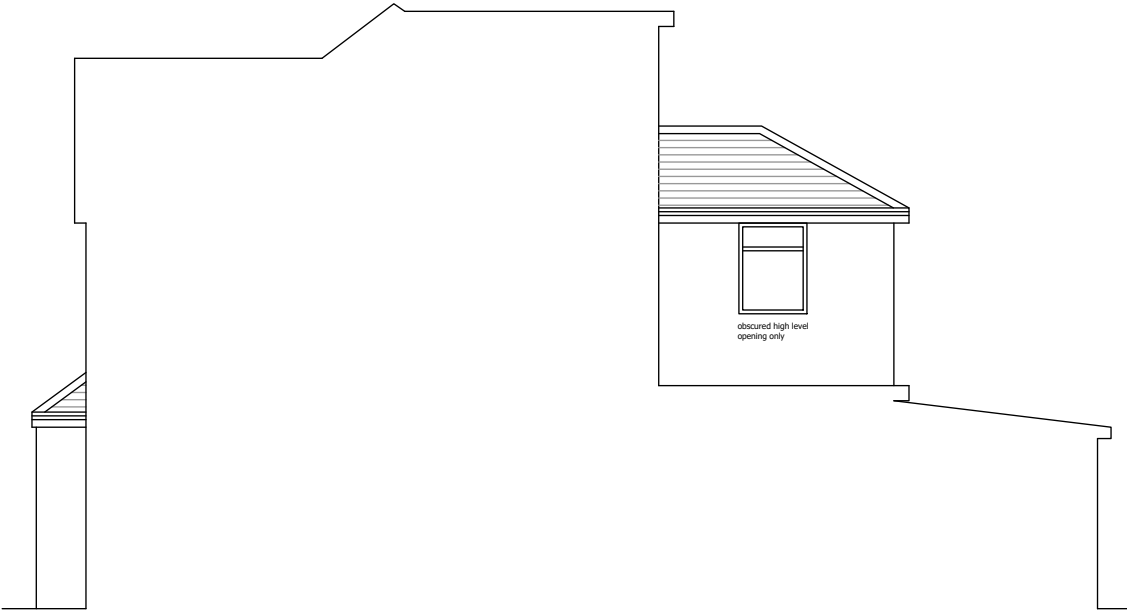

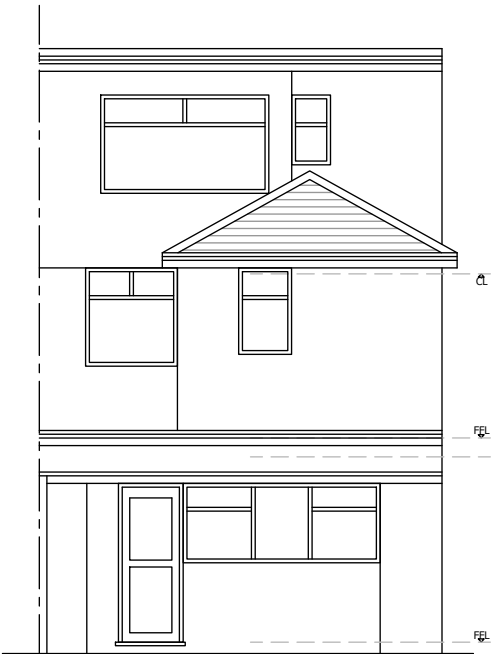

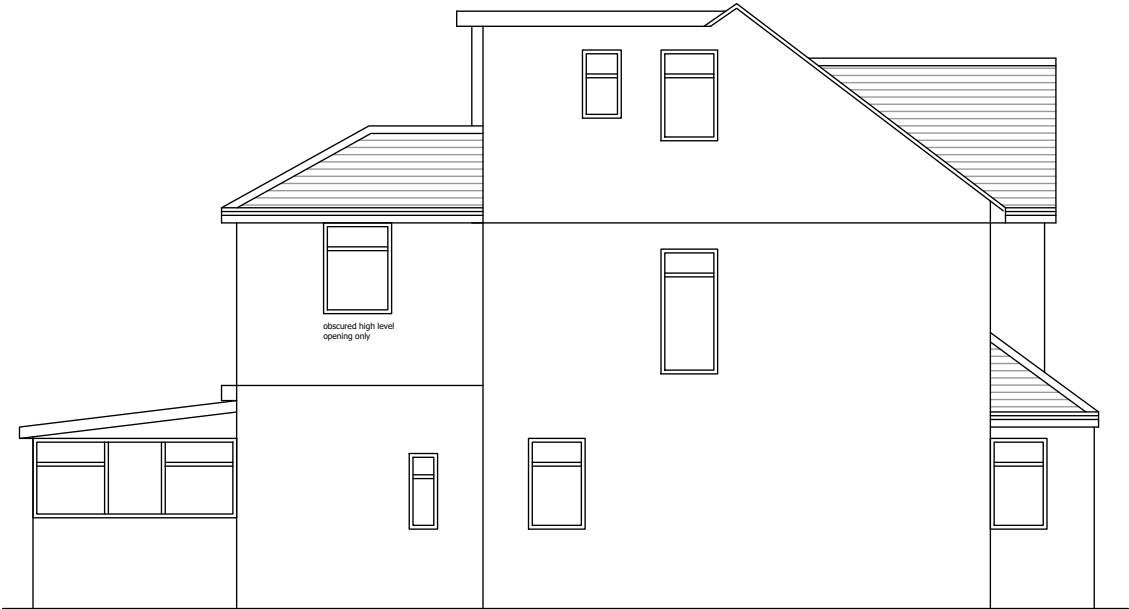

REAR ELEVATION

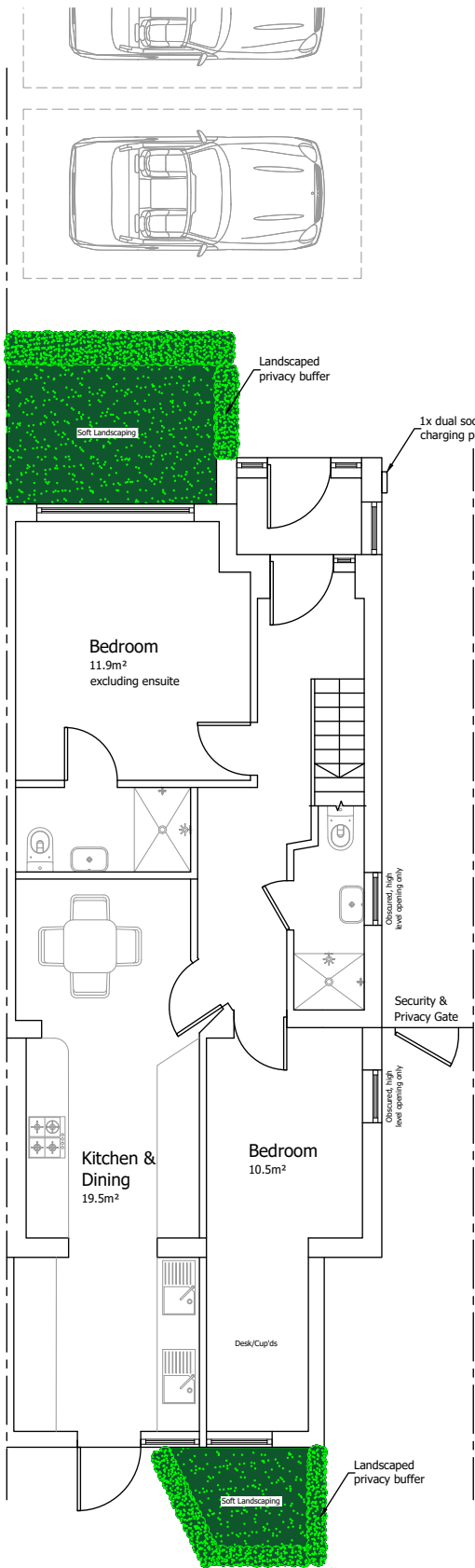

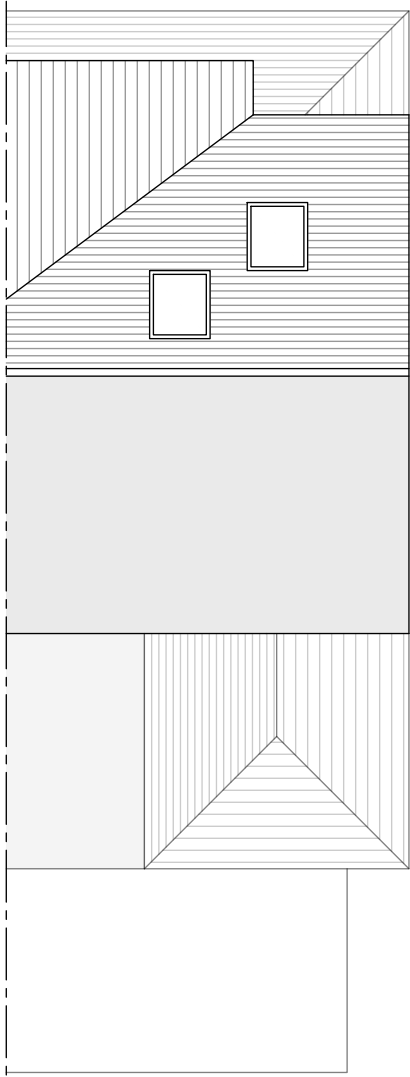
GROUND FLOOR PLAN



FIRST FLOOR PLAN

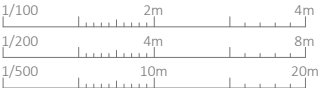


LOFT FLOOR PLAN
