Existing materials and finishes:

The existing external walls are made of brick with a pebble dash finish to the first floor, the interior is lined plaster/plasterboard. The internal partition walls are made of timber studs and plasterboard, internal structural walls are brick lined with plasterboard.

Proposed materials and finishes:

The new proposed porch extension will be in brick to match the existing ground floor, with a cavity filled with PIR, concrete internal leaf and plaster skim internal lining. New internal walls will be the same build up of timber studs and plasterboard. The new loft extension walls will consist of a timber frame, PIR insulation, vapour control layer and zinc standing seam sheets as cladding, it will be internally lined with plasterboard.

The existing roof is a timber structure and mineral wool insulation, it is clay tiled externally.

Proposed materials and finishes:

The proposed roof will be tiled with clay tiles to match the existing tiles, we will retain the timber structure and replace the existing insulation with rockwool and will line it with a vapour control layer and plasterboard. The porch extension roof will be the same buildup.

The new windows will have the same frame, made. of uPVC and will be triple glazed to decrease thermal loss.
