We received positive advice from Richard (Planning Information Officer at Hillingdon Council) on the proposal and he advised us to go straight for a householder application rather than the £480 pre app charging process. He said the following:

- 1) "I am of the opinion that the proposal will not adversely impact the amenities of the adjoining occupiers."
- 2) "I am not sure if it has been drawn up in conjunction with the design guide but this normally expects extensions on detached properties to be 4m in depth but I note your proposal has been inset to afford some subordination."
- 3) "I think we would be hard pushed to come up with a cogent reason for refusing the 4.5m extension on architectural grounds."
