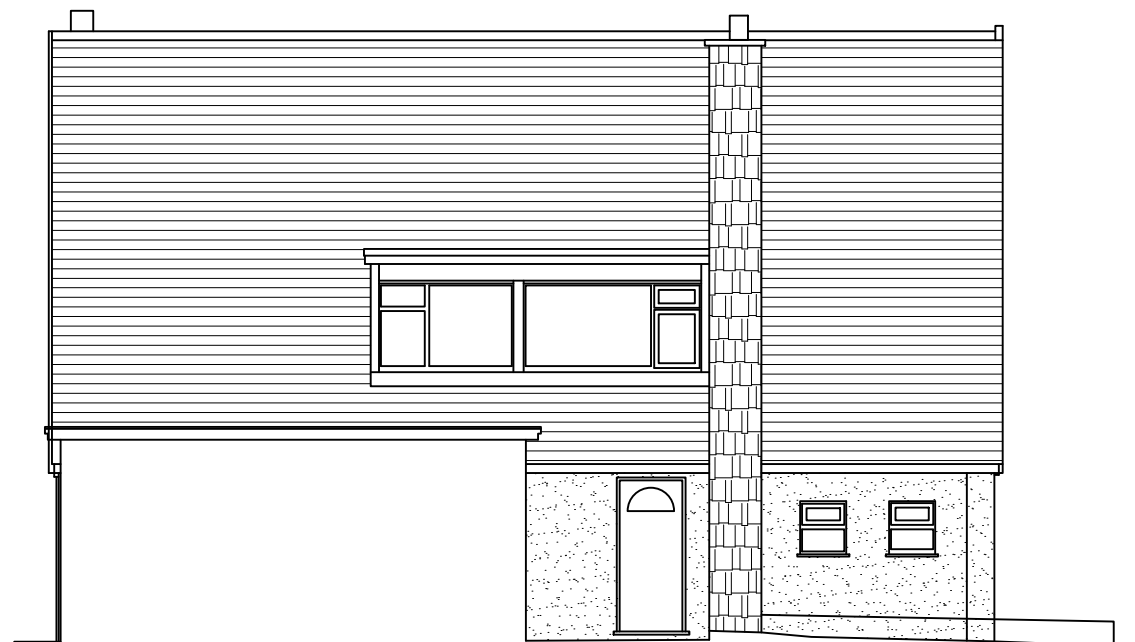
EXISTING FRONT ELEVATION (A)

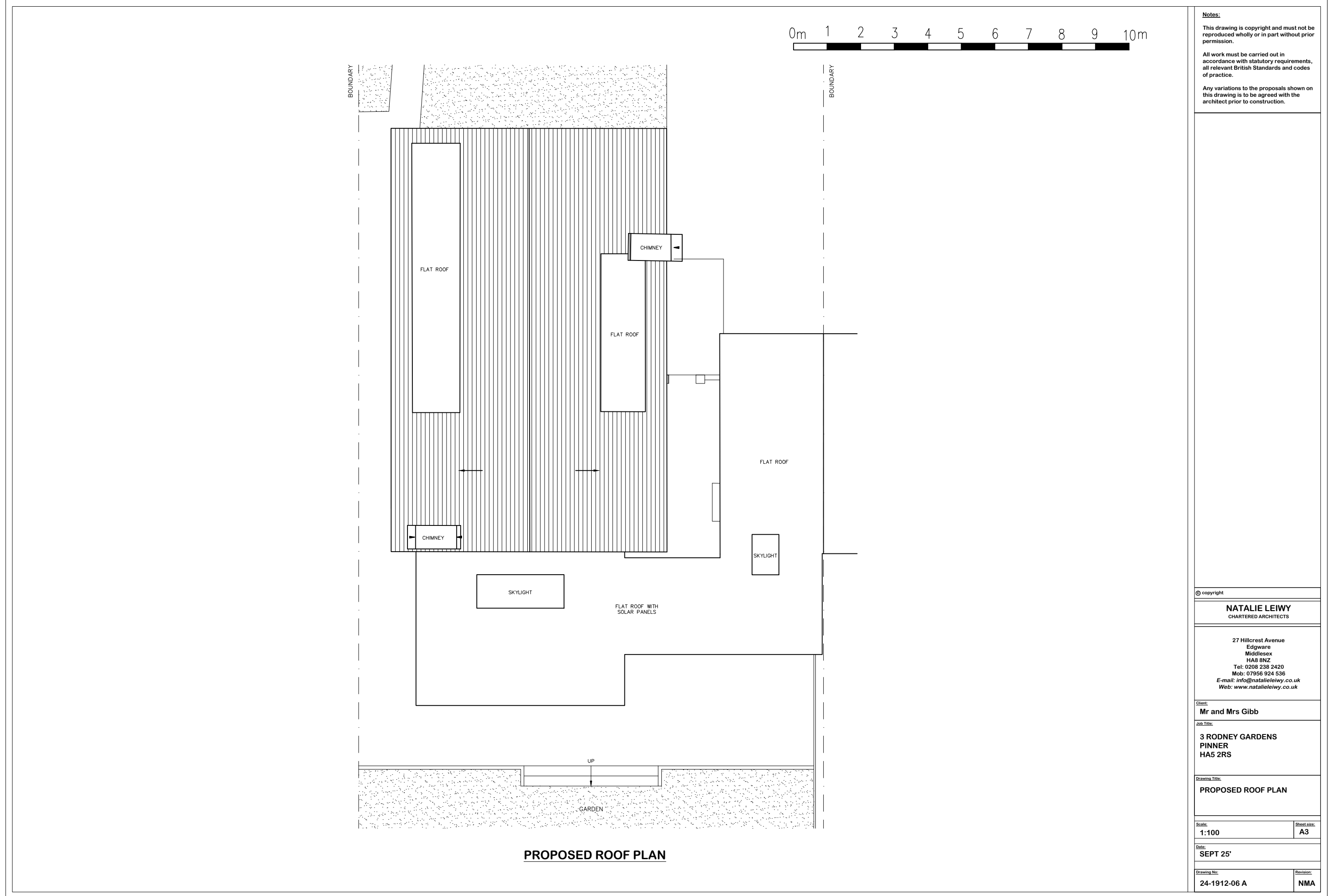

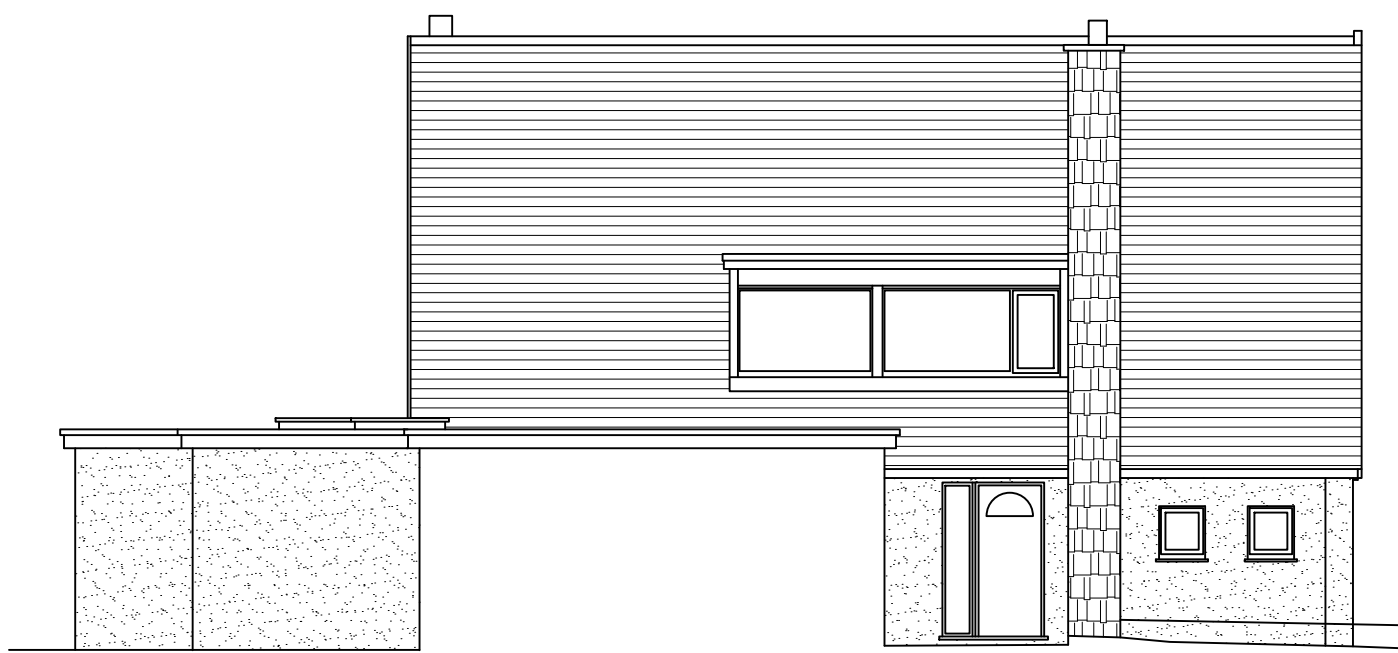
PROPOSED FRONT ELEVATION (A)
