Ther was an initial email correspondence done back 2023 with a conservation consultant from the Heritage Conservation office
Hi Myrta

Thank you for your email.

The Old School House in Moor Lane, Harmondsworth is locally listed and within the Harmondsworth Village Conservation Area.

It is locally listed for the following reason:

Statement of significance/ Reasons for designation Architectural: 19th century single storey, red and yellow brick, renewed slate roof. On elevation fronting Moor Lane: red brick, two gables with overhanging eaves, yellow brick quoins, sash windows with arched heads. Main entrance door through porch, now blocked. Brick arches over original divided sash windows. Now flats. Townscape: Contributes to the local character and street scene. Historical: The land for the school was given by Miss Ann Tillyer of The Lodge, Harmondsworth.

You do not not state the detail of how you wish to change the windows and doors. Any proposal should seek to conserve the building as an heritage asset. In essence if the windows and doors are original then they form part of the interest and significance of the building and they should be preserved. Where the windows and doors are modern there would be greater scope for alteraration provided it doesn't harm the overall character and appearance fo the building.

In general this seems fine. Ideally if the spacing in the glazing could come down a bit that would be preferable bit there is always a balance between the appearance and energy efficiency.

Id recommend to go for flush fitting casements rather than the proposed storm casements.

On the historic elements of the building Id recommend that the sashes work as sashes as there seems to be a bit of a difference on your elevation drawing and they never look good when they swing open rather than moving vertically.

Otherwise seems fine. When you submit note which windows are changing on the building, Have a short statement titled heritage statement saying that the proposals are in keeping with the character of the building/ conservation area and as such are compliant with policy.
