Details of the pre-application advice received

As set out in the above report, the proposed block is considered to be too close to the northern and southern boundaries of the site and approximately 50% of the block would adjoin the western site boundary, which would result in a cramped development that would not provide adequate amenity and outlook for future occupiers. It also creates an unappealing blank facade. The proposed development is therefore considered contrary to the good design requirements of Policies DMHB 11, DMHB 12 and DMHD 1 of the Hillingdon Local Plan: Part 2 - Development Management Policies (2020) and could not be supported by the Council.

Because of its height, width, massing, scale and siting, the proposed block is considered to overlook, cause a loss of privacy and adversely impact on the daylight and sunlight of adjacent properties. Because the proposed development would adversely impact on the amenity, daylight and sunlight of adjacent properties, it would be contrary to the requirements of Policies DMHB 11 and DMHD 1 of the Hillingdon Local Plan: Part Two - Development Management Policies (2020) and could not be supported by the Council.

The proposed communal garden would be overlooked by existing and proposed flats and is not considered to provide good quality and useable private outdoor amenity space. The proposed private outdoor amenity space provision of gardens, balconies and terraces would generally be overshadowed by and adversely affected by the proximity of the 3 storey block and are not considered to be good quality. The proposed private outdoor amenity space provision would be less than the Policy DMHB 18 requirement of 20 sqm for a studio or 1 bed flat and 25sqm for a 2 bed flat. This would be contrary to Policy DMHB 18 requirements and could not be supported by the Council.

There are also significant reservations with the likely location of proposed windows, which would have implications for natural light, sunlight, ventilation and outlook for future occupants.

To address the above design concerns, it is considered that a radically revised design is required. Any future application should include information about the current use of the site, which appears to be mainly used for car parking and currently contains 9 x garages and a single storey building that appears to be in commercial use.

For the reasons set out in the Highways section of the above report, if an application is received for the proposed development the Highway Authority would not be able to support this application.
