The design of the proposed attached dwelling, including the proposed demolition works, is considered to be generally in accordance with the principles of good design in Policies DMHB 11 of the Hillingdon Local Plan: Part 2 - Development Management Policies (2020) and would enhance the character and appearance of the site, the street scene and local area. More information is needed, but the development should not have an unacceptable impact on the amenity of the existing dwelling at no. 533 and other existing dwellings the immediate locality.

Any future application should provide details of cycle storage provision and refuse storage for no. 533 Uxbridge Road, and incorporate soft landscaping.

Demolition drawings would also be required.

For the reasons set out in the above report, and subject to conditions, the proposal could be acceptable to the Council. An application should be submitted which deals with the points raised above.
