Details of the pre-application advice received

It was discussed in the meeting and report that a fully brick built structure of same depth may not be acceptable. Therefore, to combat this we have designed a modern glazed conservatory style structure, similar to existing with only brick corner supports which has the same or less visual impact on neighbours and amenities. This has been further explained on a daylight/sunlight report which shows no negative impact to neighbours. Now that the new scheme has more glazing the light of the internal spaces remains the same as existing or better.
