Why do you consider that a Lawful Development Certificate should be granted for this proposal?

- The materials will be similar in appearance to the existing house.
- The rear extension will not exceed more than four metres beyond the rear of the original house.
- The rear extension will not exceed the height of the existing roof and eaves or when within two metres of a boundary will not exceed three metres in height to the eaves and 4 metres in height overall.
- The rear extension will not be built forward of any principal elevations facing a highway.
- The extension and/ or other buildings will cover less than half of the area of land around the original house.
- The proposed volume of enlargement will not exceed the original roof space by more than 50 cubic metres.
- The proposal will not exceed the height of the existing roof.
- On the principal elevation of the house (where it fronts a highway), the proposal does not extend beyond the existing roof slope.
- The proposal does not include: verandas, balconies or raised platforms; or installation, alteration or replacement of any chimney, flue, or soil and vent pipe.
- Any proposed side-facing windows will be obscure-glazed; and, if opening, to be 1.7 metres above the floor of the room in which they are installed.
- The construction of the proposal will ensure that: The eaves of the original roof are maintained (or reinstated), Any enlargement is set back, so far as practicable, at least 20cm from the original eaves, and that the roof enlargement does not overhang the outer face of the wall of the original house.
- The proposal is not within Article 2(3) designated land.
