Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Oak (T001) - Remove lowest primary branch extending north, circa.100mm diameter. Crown lift to 5m agl by the removal of secondary and tertiary branches. Tip back southwest aspect of crown over play area by no more than 2m to suitable pruning points, ensuring a flowing branchline is maintained and as shown in the photographs at section 3.7 of report ref: 11132. (Remove deadwood and Ivy - for notification purposes only).

Oak (T002) - Crown lift to 5m by the removal of epicormic stem growth and secondary and tertiary branches shown in the photographs at section 3.8 of report ref: 11132. (Remove deadwood - for notification purposes only).

Oak (T003) - Crown lift by the removal secondary and tertiary branches shown in the photographs at section 3.9 of report ref: 11132. (Remove major deadwood overhanging rear garden of 9 Ravenscourt Close - for notification purposes only).

Reason - To gain greater clearance over the rear garden and improve light levels to both the garden and dwelling. Please refer to attached report ref: 11132.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
