Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The proposal is deemed lawful as the width of the proposed side extension will be approx. 1.71m which is considerably less than half the width of the original house (approx. 6.1m).

A 0.9m gap will be retained on the flanking wall of the extension, parallel to the side boundary, for access which matches the side access retained with the previously approved application (ref: 31647/APP/2015/1632).

Also as the proposed extension is within 2m of the side boundary the eaves height will be approx. 2.805m (ie. under 3m)
