The proposed development, including side, front, and rear extensions, as well as dormer conversions, has been reviewed in the pre-application report. The side extension, though built up to the boundary, is considered acceptable with material matching the existing dwelling and a roof design that may require further adjustment to maintain subordination. The front porch and relocation of the entrance are deemed appropriate in terms of design. The rear extension, modest in scale, is acceptable subject to a recommended 1m setback from the front elevation, ensuring it remains subordinate. The dormers are generally supported, though one dormer at the front requires redesign due to its bulky appearance. The proposal has no significant impact on neighbouring properties in terms of amenity, daylight, or privacy. Concerns about the introduction of hardstanding and impact on greenspace were raised, though a parking spot in front of the entrance is acceptable. Overall, the scheme is considered sympathetic and harmonious with the existing dwelling and street scene, provided the recommended amendments are incorporated.
