Details of the pre-application advice received

The submitted drawings indicate that existing single-storey rear extension is to be demolished and appear to indicate that three outbuildings will be demolished. However, no drawings, floorspace /volume information, photographs or historic details about the three outbuildings has been submitted. Therefore, the submission fails to demonstrate that the proposed development could be considered to constitute 'appropriate development' within the Green Belt. Unless drawings, floorspace / volume information, photographs or historic details about the three outbuildings are submitted to demonstrate that the proposed development could be considered to constitute 'appropriate development' within the Green Belt, the proposed development would be considered contrary to the requirements of Policy DMEI 4 of the Hillingdon Local Plan: Part Two - Development Management Policies (2020) and could not be supported by the Council.

According to the Council's GIS, the site lies in the Functional Flood Plain of the Frays River (Flood Zone 3b). Development in Flood Zone 3b will be refused in principle unless identified as an appropriate development in Flood Risk Planning Policy Guidance e.g. Essential transport infrastructure, essential utility infrastructure, wind turbines and solar farms. On this basis, the proposed porch and single-storey rear and side extension are not considered to be appropriate development in Flood Risk Planning Policy Guidance terms. Therefore, the proposed development would not accord with the requirements of Section 14 Meeting the challenge of climate change, flooding and coastal change of the National Planning Policy Framework, Policy SI12 of the London Plan (2021), Policy EM6 of the Local Plan: Part 1 - Strategic Policies (2012) and Policy DMEI 9 of the Hillingdon Local Plan: Part 2 - Development Management Policies (2020) and could not be supported by the Council.

Objections are raised with regard to the visual impact and design of the proposals, particularly with regard to the impact on the character and appearance conservation area which the development must preserve in all views, both public and private.

River View is located within the Colne Valley Archaeology Priority Area and the Greater London Archaeological Advisory Service (GLAAS) would need to be consulted on any future application.
