Details of the pre-application advice received

The principle of development is may be acceptable subject to further justification of Policy DMH 6 of the Local Plan: Part 2 - Development Management Policies (2020). The submission of an amended design that addresses concerns for neighbouring amenity and provides tree and landscaping information. The optimisation of the site, which would involve an uplift of residential accommodation within the site is welcomed.

The onsite amenity of the primary living spaces of Units 3 & 4 as well as their respective outdoor living areas is considered to be poor and the current layout is not supported.

The proposed depth of Unit 1 & 2 is not supported due to impacts on the openness of the area by exceeding the rear building line.

Revisions to the design and materials of the dwellings, to ensure they are harmonious with neighbouring dwellings and the surrounding area would be required.

Additional information is required with regard to justification of demolition, feasibility of the proposed access and impact on trees and landscaping on the site.

Overall, the scheme is not supported and requires amendments.
