Tree number - G1
Tree type - Cypress (x Cupressus leylandii)
Approx Height - 10m
Location - Front garden, Front boundary
Service - Hedge Trimming
Work required- Level top edge on clients side by removing upto 0.25m and sympathetically trim clients side of hedge without losing green foliage cover.
Reason - As part of regular maintenance

Tree number - H1
Tree type - Cypress (x Cupressus leylandii)
Approx Height - 5-6m
Location - Front garden, Right hand boundary
Service - Hedge Trimming
Work required- Trim client side without losing green foliage cover
Reason - As part of regular maintenance

Tree number - T1
Tree type - Oak (Quercus robur)
Approx Height - 14m
Location - Rear garden, Right hand boundary
Service - Dead wood
Work required- Remove all deadwood over 40mm in diameter and/or 1m in length. Reduce crown all round by upto 1.5m, pruning to suitable growth points/branch fork junctions.
Reason - To maintain compact form, As part of regular maintenance

Tree number - G3
Tree type - Cypress (x Cupressus leylandii)
Approx Height - 8-15m
Location - Rear garden, Left hand boundary
Service - Hedge Trimming
Work required- Trim clients side hard back as possible, as high as can safely be reached with pole tools, without losing green foliage cover.
Reason - As part of regular maintenance

Tree number - T6, T7 and T8
Tree type - 3x Birch (Betula pendula)
Approx Height - 10m
Approx Crown Spread Diameter - 4m
Location - Rear garden, Left hand boundary
Service - Crown Reduction
Work required- Reduce and shape height by approx 1.5m. Pruning to suitable growth points.
Reason - As per customers wishes, to maintain at a manageable size for the space.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
