Tree number - G1
Tree type - Cypress (x Cupressus leylandii)
Approx Height - 10m
Location - Front garden, Front boundary (within 4 Rogers Ruff)
Service - Hedge Trimming
Work required- Level top edge on clients side by removing upto 0.25m and sympathetically trim clients side of hedge without losing green foliage cover.
Reason - As part of regular maintenance

Tree type - Cypress (x Cupressus leylandii)
Approx Height - 5-6m
Location - Front garden, Right hand boundary (within number 6 Rogers Ruff)
Service - Hedge Trimming
Work required- Trim client side without losing green foliage cover
Reason - As part of regular maintenance

Tree Number - T5
Tree Type - Poplar (Populus alba)
Approx. Diameter at 1.5m - 30cm
Approx. Height - 17m
Approx. Crown Spread Diameter - 10m
Location - left hand boundary, neighbours garden (17 Nicholas way)
Service - Crown Reduction
Work Required - Reduce height by up to 2m to leave the tree at 15m height and reduce lateral spread overhanging 5 Rogers Ruff by around 2m.
Reason - To reduce risk of subsidence to property (as per survey report) and to reduce encroachment/debris over roof of main house.
Priority Code - B

All resulting brushwood and logs will be transported to our recycling depot awaiting transfer to Thetford Power Station to be used as bio-fuel (**unless otherwise stated in work description above**).
