Work required- Trim face of hedge facing clients property hard back as possible, without losing green foliage cover.

Reason - As part of regular cyclical maintenance

Priority code - on

Tree type - Cypress (x Cupressus leylandii)

Approx Height - 5-6m

Location - Front garden, Right hand boundary (within number 6 Rogers Ruff)

Service - Hedge Trimming

Work required- Trim clients side without losing green foliage cover

Reason - As part of regular maintenance

Tree number - T4

Tree type - Ash (Fraxinus excelsior)

Approx Height - 12m

Location - Rear garden Rear boundary right hand side

Service - Crown Reduction

Work required- Reduce and shape height by around 2.5m.

Reason - To reduce wind sail and lever action on weak/included unions.

Tree Type - White Poplar (Populus alba)

Approx. Height - 12m

Approx. Crown Spread Diameter - 8m

Location - 17 Nicholas Way

Service - Crown Reduction

Work Required - Reduce height by around 2.5m and reduce lateral growth over 5 Roger's Ruff hard back by around 2m.

Reason - To reduce encroachment over property and debris on roof/guttering.

Tree Type - Birch (Betula pendula)

Approx. Height - 10m

Location - Left hand boundary

Service - Section dismantle

Work Required - Section dismantle tree to near ground level

Reason - 3x Fungal fruiting bodies at base of stem (Ganoderma australe) with extensive audible hollowing noted. To prevent failure and potential damage to building.

Priority Code - A

Tree number - G3

Tree type - Cypress (x Cupressocyparis leylandii)

Approx Height - 8m

Location - See map

Service - Hedge Trimming

Work required- Trim lateral growth on the face nearest 5 Rogers Ruff hard back as possible without losing green foliage cover.

Reason - As part of continued maintenance, to reduce encroachment and debris over building/guttering

Priority code - on.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
