The proposals involve replacing the pebble dash finish to the main house with a smooth render finish (white/off white in colour). This affects the first floor of the property only, where the existing pebble dash exists on the front side and rear elevations.

The proposals also invlove erecting a outdoor building/shelter in the rear garden, approximately 6m (L) x 4m (W) x 2.5m (h) in size. The proposed structure will consist of rendered concrete blockwork with a smooth Render Finish (Off white colour - to match the proposals to the main house), Felt Roof with Timber Battons & Timber Trellis Fence Panels. The outdoor building/shelter will contain a barbeque area and outdoor garden seating.
