PRE-APPLICATION ADVICE WAS SOUGHT THIS YEAR AND I HAD AN ONLINE MEETING 21ST JULY ( REFERENCE 32647/PRC 2022/135) FOR A 3M REAR EXTENSION AND A LOFT CONVERSION.

THE PLANNING OFFICER SAID A LOFT CONVERSION WITH GABLE ENDS AS I PROPOSED WOULD NOT BE ACCEPTABLE NOR WOULD A MANSAARD-STYLE ROOF. HE SUGGESTED I COULD EXTEND 4M ON THE REAR. AND EXTEND TO ONE SIDE LEAVING A GAP FROM THE BOUNDARY AND SUGGESTED A FLAT ROOF RATHER THAN A SECONDARY PITCHED ROOF.

I TOOK HIS ADVICE AND REVISED THE PLANS ACCORDINGLY.
