Tree type - Sycamore (Acer pseudoplatanus) and hawthorn (Crataegus)
Approx Height -14-16m
Location -neighbouring trees (10 Amberley Way, UB10 0BB)
Service - Cut Back
Work required - To cut back all lateral overhanging branches back to boundary to good growth branch fork junction
Reason -as per clients instructions as part of continual maintenance

Tree number - G2
Tree type - mixed, 2x whitebeam (Rosaceae) and 5 x cherry (prunus avium)
Approx Height -12-14m
Location - left hand boundary of garden and property
Service - Cut Back
Work required -To cut back all overhanging growth back to boundary to good growth/fork junction by approx 2-3m
Reason -to contain and control as per clients instructions

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
