Relocate/reprovide two existing side-facing windows that would be affected by the approved first-floor side extension. The proposed windows will serve the same internal rooms and will be similar in style and appearance to the existing windows. The amendment is required because, during preparation for construction, it was identified that the approved side extension would result in the loss/blocking up of two existing side-facing windows. These windows currently provide natural light to existing internal rooms. The proposed amendment seeks to relocate/reprovide windows to continue serving those same rooms, while keeping the approved footprint, scale, massing and overall design of the development unchanged.
